<u>Ferry Lane (South) and Coldharbour Lane</u> - Proposed Raised zebra crossings and parking bays

I am writing to advise you that the Council are proposing to introduce raised zebra crossings, raised road surfaces and free parking bays with parking limited to 3 hours between Monday and Saturday, 8.00am to 6.30pm along Ferry Lane South and Coldharbour Lane as shown on the attached plans. The relevant notices and notice of proposals are also attached to this letter. The zebra crossings will provide pedestrian crossing facilities to connect the Strategic pedestrian route from Rainham Marshes to River Thames. These proposals have been designed to improve pedestrian facilities and prevent uncontrolled long term parking.

ZEBRA CROSSING ON FERRY LANE AND COLDHARBOUR LANE, RAINHAM

- 1. Notice is hereby given that the Council of the London Borough of Havering ("the Council"), under Section 23 of the Road Traffic Regulation Act 1984, proposes to install a new humped Zebra Crossing with zig-zag road markings on Ferry Lane and a Zebra Crossing with zig-zag markings on Coldharbour Lane as detailed in schedule 1 of this notice, to improve the safety of pedestrians.

Ferry Lane, Rainham	Installation of a new humped zebra crossing and associated zig-zag markings will be placed either side of the crossing in Ferry Lane near to No 1 Easter Industrial Park, Rainham.
Coldharbour Lane, Rainham	Installation of a new zebra crossing on an existing speed table and associated zig-zag markings will be placed either side of the crossing in Coldharbour Lane near to No 7 Easter Industrial Park/ Harbour House, Rainham.
